The Suryodaya Municipality, Office of the Municipal Executive invites Electronic bids for works as indicated in details of work below by NCB-Single Stage Single Envelope Bidding procedures and for the **Upgrading of Barbote Kattebung Chiruwa Road** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures as in accordance with e-GP Procurement Directive 2074.
